

[PAssion POSB Debit Card] 50% off All Park Admission Tickets Terms & Conditions

- Promotion is valid from 04 December 2024 to 31 December 2025.
- Limited to the first 200 Adult & 100 Child admission ticket purchase per Park, per month, while stocks last.
- 50% off admission ticket pertains to cardholders paying only 50% for Adult or Child type admission tickets only across Bird Paradise, Singapore Zoo, River Wonders and Night Safari.
- Customers must pre-book their date and time of visit (for Night Safari).
- All tickets are inclusive of in-park tram / shuttle rides.
- River Wonders ticket does not include Amazon River Quest boat ride; ride must be purchased separately.
- Tickets can be utilised on all days, subject to pre-booking availability, except the eve of and during Public Holidays.
- Each ticket is valid for redemption once only before stated expiry date — no extension of validity will be granted.
- All other Terms & Conditions stated on the e-ticket must be adhered to.

PAssion POSB Debit Cardholders Terms and Conditions
